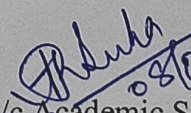
NOTICE

Based on the merit and choice of programmes exercised by the candidates, **the provisional 2nd round selection list** for admission to different programmes under ITEP 2026-27 have been prepared and published on websites of RIE Bhubaneswar and ITEP admission portal of RIE Bhubaneswar. Candidates are required to complete the admission process by following the steps mentioned below within the prescribed schedule. Failure to comply with the stipulated instructions or timelines will result in the cancellation of your provisionally allotted seat, and no further claim for admission shall be entertained.

1. Login to ITEP admission portal to download your Provisional Allotment Letter and pay the provisional admission fees of ₹ 13,585/- (₹ 8,585/- for ST/SC candidates) **before 11-08-2026 (11:59 PM).**
2. Exercise your option for Freeze or Float **before 11-08-2026 (11:59 PM).**
3. Freeze:- Option for confirmation of allotted seat & no further upgradation.
4. Float:-Option for upgradation & participation in the subsequent rounds.
5. Once you choose (Freeze/Float), you cannot change further.

Note:-

1. The allotment letter is purely provisional and does not, by itself, confer any right to admission to the allotted programme. Admission shall be granted only after the candidate successfully pays the prescribed provisional admission fee, obtains the Provisional Admission Intimation Letter, completes the physical verification of all original documents, and fulfil all other prescribed admission formalities to the satisfaction of the Institute. Refund of the provisional admission fee shall be processed in due course if a candidate is found ineligible or otherwise not suitable for admission to any programme under ITEP 2026-27 during the admission process.
2. If, at any stage, it is found that a candidate has submitted any forged, fabricated, or fake document(s), the provisional allotment/admission shall be cancelled immediately. The candidate shall also be debarred from admission, and appropriate legal and/or disciplinary action may be initiated in accordance with the applicable laws and the Institute's rules.
3. If, at any stage, it is found that a candidate has suppressed any material information or knowingly furnished false information or documents, his/her candidature or admission shall be cancelled forthwith, irrespective of the stage of the admission process or course of study, even if such suppression or misrepresentation is detected after the completion of the admission process.
